

SOCIAL WORKER

Every summer, in Philadelphia, there are over 500 streets designated as Playstreets that are run by Philadelphia Parks & Recreation (PPR). Playstreets are closed to traffic and open to neighborhood children where they can play together and receive a meal. Fab Youth Philly (FYP) partners with PPR to provide children a more engaging and fun environment on Playstreets through our Play Captain Initiative (PCI).

This summer we are hiring Licensed Clinical Social Worker to support both adults and teens as they do their job on the Playstreets or at Parks & Playgrounds.

PLEASE NOTE:

This is a part-time, temporary, seasonal, hourly position with an average of 25 hours per week. Interviews will take place virtually; training and employment will be in-person following Covid-19 safety protocols. Candidates must be available to work in a variety of outdoor conditions on a daily basis. This position requires availability from **June 14 through August 17, 2021** with a typical work schedule of Monday through Thursday from 9:30 am to 4:30 pm and on Fridays from 9:30 pm to 1:00 pm.

Salary will be \$35/hour.

Applications are due by **May 15, 2021**.

FYP will provide paid training that will include important COVID-19 safety protocols such as wearing a mask/face covering at all times both indoors and outdoors.

Responsibilities include the following but are not limited to:

Counseling (95%)

- **Develop** supportive relationships with both youth and adults
- **Coach** Group Leaders to use a strengths-based approach for supporting the teens they work with
- **Provide guidance** to the Executive Director when Fab Youth Philly is developing plans for dealing with traumatic events both nationally and locally
- **Help** staff work through vicarious trauma including, but not limited to facilitating and holding space for processing
- **Provide 1:1** brief supportive counseling to both Fab Youth Philly adult staff and Fab Youth Philly teen, Play Captains experiencing stress and or/ trauma
- **Collaborate** with teens, FYP staff and community partners to accomplish these duties.

Administrative & Organizational (5%)

- **Uphold** COVID-19 safety protocol
- **Completes all documentation** in a timely manner that is legible, clear and organized according to FYP and legal standards.

Knowledge-Skills-Abilities:

- Knowledge of Positive Youth Development Principles
- Knowledge of adolescent development
- Knowledge and use of trauma-informed practice skills

- Use of strengths- based approach
- Uphold Social Work Code of Ethics
- Ability to work independently and be a team player
- Ability to serve as a positive role model
- Reliable and trustworthy with a strong work ethic

Requirements:

- Must hold highest level of Pennsylvania licensure, a LCSW.
- Must hold professional liability (malpractice) insurance with coverage at a minimum of \$500,000/occurrence and 1,500,000 aggregate.
- Minimum of 2-years' demonstrated experience providing trauma-informed counseling to teens
- Willing and able to work outdoors in all kinds of summer weather (hot, rainy, humid, limited shade)
- Willing and eager to learn about a new/unfamiliar neighborhood
- Willing to be trained in, and use 'real-time coaching' and positive youth development strategies
- Able to remain calm and patient to navigate conflict and bring forth resolutions
- Access to reliable phone/internet service to respond to emails within 24 hours and to send/receive text messages
- Willing and able to get around Philadelphia independently; has reliable mode of transportation

Education Requirements:

Master's Degree from a Council of Social Work Education (CSWE) accredited institution.
